In this regard, the college has an MOU with Garbage Free India, an NGO dedicated to the proper disposal and recycling of different types of wastes. The college has also signed a contract with Hulladek and Vital Waste, companies that deal with proper disposal and recycling of different types of wastes including Electronic waste (E-waste).

#### 2. Aim

The College aims to implement an Artificial Intelligence (AI) based waste management system in near future to optimize waste collection, segregation, and disposal, promoting a more sustainable and efficient waste management process.

## 3. Objectives

- To comply with the waste management guidelines and regulations prescribed by the Pollution Control Board of West Bengal.
- To reduce waste generation through sustainable practices and awareness programs.
- To ensure the segregation, collection, storage, and disposal of waste in an environmentally responsible manner.
- To promote recycling and reuse of refurbished materials to minimize the waste sent to landfills.
- To engage the college community in waste reduction initiatives and educational programs.

This policy applies to all students, staff, faculty, contractors, and visitors of Maulana Azad College.

### 4. Waste Segregation

- General Waste: Non-recyclable waste that will be collected and disposed of through authorized municipal waste management services.
- Recyclable Waste: Paper, cardboard, plastics, metals, and glass should be separated and placed
  in designated recycling bins.
- Organic Waste: Food waste and other biodegradable materials will be composted on-site or sent to authorized composting facilities.
- Hazardous Waste: Chemical, electronic (E-wastes), and other hazardous wastes will be handled and disposed of according to specific guidelines provided by the Pollution Control Board of West Bengal.

## 5. Waste Collection and Storage

- Clearly marked bins for different types of waste will be placed at strategic locations throughout the campus.
- Waste will be collected regularly to prevent overflow and maintain hygiene.
- Designated storage areas for recyclable and hazardous waste will be established to ensure safe handling until disposal or recycling.

## 6. Waste Disposal

- General waste will be collected by municipal waste management services and disposed of in designated landfills.
- Recyclable waste will be sent to Vital Waste under the aegis of GFI and Hulladek in case of E-wastes
- Organic waste will be composted on-site or sent to composting facilities.
- Hazardous waste will be managed and disposed of in compliance with regulations to prevent environmental contamination.

## 7. Recycling and Reuse

- The college will promote the reuse of materials such as paper, glass, and plastic through awareness campaigns and practical initiatives.
- A recycling program will be established to collect and process recyclable materials efficiently in collaboration with our waste management partners.
- The college encourages reuse and repurposing of refurbished dustbins for planting saplings.
- Organic waste composting and recycling bank facility (with AI base chip sensor) to be installed within college premises.
- Leaf composting facility to be installed within college premises.
- Workshops and training sessions on waste reduction and recycling will be conducted for students and staff.

#### 8. Awareness and Education

- Regular seminars, workshops, and awareness campaigns will be organized to educate the college community on waste management practices.
- Information on waste segregation, recycling, and disposal will be disseminated through posters, brochures, and the college website.
- Student clubs and organizations will be encouraged to participate in and lead waste management initiatives.

### 9. Compliance and Monitoring

- Regular audits will be conducted to ensure compliance with waste management practices and identify areas for improvement.
- The Waste Management Committee will be responsible for monitoring waste management activities and implementing corrective actions when necessary.
- Compliance with the Pollution Control Board of West Bengal's guidelines will be periodically reviewed and reported.
